Being prepared for this kind of situation is always a plus and up here it is better to be safe then sorry. Some recommendations for Winter survival:

Carry chains in your vehicle; even if you have 4WD

Keep a coat/hat/gloves handy

Keep your cell phone charged and make sure you have your neighbors phone numbers

Watch the weather report—sometimes they're right

May want to look at some snow fence if your place drifts

Have a generator that is fueled and ready to plug important appliances into—like the coffee pot

Perfect Time To Burn Those Slash Piles

Take advantage of the wet conditions and get your slash piles burned now! If you have any questions on how to do this safely please talk to Dwight Day at 780-0112.

Although the county does not require you to get a burn

permit, a courtesy call to the Sheriff's Office in Columbus to let them know you are doing a "controlled burn" is the wise and neighborly thing to do.

Notifying the county alerts the Fire Department that you are burning and not to send the trucks and it is also good for your neighbors when smoke calls are received and they can relax and know that it is not a wild fire. Call 322-5326 County Dispatch open 24-7 for info..

The earlier the Weed Committee and landowners can start the better off the ranch will be for weed control.

There are several individuals that are Certified Weed

Sprayers on the ranch. The county has equipment that can be borrowed for FREE that can be put on your quad, tractor, back of your truck, plus back packs.

If the landowners were to get together and have a weed day to spray the roads, the Association would only have to buy the chemicals needed and not have to hire a company to come out and spray. Volunteers are needed to get this done. Call Cleve Schuster at 670-5172.

State law requires all landowners to have a weed plan and to control them.

You are required to have a Use Permit (good for a year) as a user of the property given by FWP, Cleve Schuster is checking to see if the Ranch can buy a single group permit for all landowners to use.
